Terms of Application

The PROFASHIONALPASS is issued in cooperation with the interest group ModeCentren e.V. and Modemedia GmbH with the support of the Federal Association of the German textile Retail Trade (Bundesverband des Deutschen Textileinzelhandels e.V. – BTE) by Wirtschaftsdienst Mode GmbH (WDM), Hamburg, who is and shall remain owner of this pass.

The PROFASHIONALPASS shall be issued to purchase-entitled owners, managing directors and permanent employees in the textile, clothing, accessories, footwear and leather goods trade as well as large enterprises (e.g. department stores, large mail order firms). The pre-condition for meeting this criteria is that the applicant makes annual textile, clothing etc. purchases worth at least Euro 25,000.– (net) or accessories, shoe and leather goods purchases worth at least Euro 10,000.– (net). Other conditions depend of the type of company applying: furnishing evidence of current store premises, entry in the trade registry, trading licence, please see details listed in the guidelines presented at every PROFASHIONALPASS service centre. The processing PROFASHIONALPASS service centre is entitled to demand relevant evidence from the applicant. No legal right for application acceptance exists in respect of the relevant PROFASHIONALPASS service centre or the WDM.

The PROFASHIONALPASS gives the cardholder plus one accompanying person, as a member of the named professional sector, the right, on the territory of the Federal Republic of Germany, to visit fashion centres and trade fairs as well as other facilities and events access to which is reserved to professionals in this sector, insofar as a relevant agreement exists between WDM and the relevant organizer. This shall not override the obligation for payment of any entrance fees charged.

The application for the issue of the PROFASHIONALPASS can only be processed provided the pass application is completed truthfully and in full and the processing fee of current per pass are enclosed as a crossed cheque in addition to the required credentials.

Should false data knowingly be supplied in conjunction with the application of the PROFASHIONALPASS, criminal proceedings shall be instigated and/or a precautionary ban imposed for all fashion centres connected to the interest group ModeCentren e.V. and at relevant trade fairs.

The PROFASHIONALPASS shall serve as a data carrier. On request identity must also be shown. In addition to the pass holder, the PROFASHIONALPASS shall admit only one further person permanently employed by the company in an accompanying capacity. The PROFASHIONALPASS is not transferable.

The pass may not be used to meet private demand.

Any loss of the PROFASHIONALPASS must be reported immediately to the issuing office (WDM, Modezentrum oder Igedo Company GmbH & Co. KG). Any change to the data supplied in this application must also be reported.

I/we hereby apply for a PROFASHIONALPASS explicitly recognising the above and below terms of application. I/we are cognisant of the fact that:

- 1) my/our company and personal application data required for the issue of the PROFASHIONALPASS as well as
- 2) the violations leading to withdrawal of the PROFASHIONALPASS will be stored electronically pursuant to the provisions of the Federal Data Protection Law (Bundesdatenschutzgesetz BDSG) on behalf of the Wirtschaftsdienst Mode GmbH (WDM);
- 3) the capture of all this data is performed by the offices of the interest group ModeCentren e.V. and by Igedo Company GmbH & Co. KG on behalf of Wirtschaftsdienst Mode GmbH (WDM).

I/we agree that

- 1) this data can be captured, processed, utilized and evaluated by the Wirtschaftsdienst Mode GmbH (WDM), the interest group ModeCentren E.V. and Modemedia GmbH (Igedo Company) and the Federal Association of the German Textile Retail Trade (Bundesverband des

In the event of the PROFASHIONALPASS holder leaving the company, the company of the applicant being sold or closed, the PROFASHIONALPASS must be returned immediately to the issuing office.

The PROFASHIONALPASS can be withdrawn should:

- a) it be lent or passed on to the non-entitled third parties;
 - b) several PROFASHIONALPASSES have been issued at different fashion centres and/or at Modemedia GmbH on the basis of the presentation of false data;
 - c) debts due for payment by member companies (lessors at fashion centres) fail to be paid, despite a legally valid reminder or acknowledgement;
 - d) cheques or bills of exchange be repeatedly contested;
 - e) the house regulations at fashion centres or trade fairs be repeatedly violated with intent;
 - f) the applicant have submitted a statutory declaration in lieu of oath or should insolvency proceedings have opened on the assets of the applicant or should corresponding petitions be dismissed for lack of funds.
- Alterations and/or deletions to the application conditions in this application form as well as reservations or conditions made by the applicant shall hereby be explicitly opposed by the WDM.

In the event of the publisher and his co-operation partners and vicarious agents committing only a negligent breach of duty, their liability shall be limited to the typical contractual, foreseeable damage.

Should the applicant be a merchant, a legal person under public law or a special fund under public law, Hamburg shall be agreed as the place of jurisdiction for all disputes concerning, arising from and also in connection with this Agreement – also for contested cheques and bills of exchange. The WDM does, however, have the right to take action against the applicant at another place of jurisdiction valid for the latter.

Should the applicant not be a merchant, a legal person under public law or a special fund under public law, Hamburg shall be agreed as the place of jurisdiction if the applicant

- had no place of general jurisdiction in the Federal Republic of Germany on concluding the Agreement
- had moved his domicile or normal place of residence subsequent to concluding the Agreement or
- his domicile or normal place of residence is not known on commencement of an action.

The Agreement is governed by the law of the Federal Republic of Germany. Alterations and/or amendments to the Agreement must always be made in writing. This shall apply equally to the lifting of this stipulation requiring written form. Should one of the above or below provisions be or become inoperative, this shall not, in case of doubt, affect the validity of the remaining provisions. Moreover, in the stead of the inoperative provision a valid provision coming as close to its purposes shall apply. Photos are part of the application and remain with the WDM GmbH.
